3. Accordingly, officers and other ranks are forbidden:
 - (a) To insert advertisements or letters in any publication inviting strangers to communicate with them;
 - (b) To enter into correspondence with strangers in response to advertisements or other invitations;
 - (c) In any other way to communicate with strangers by letter or otherwise concerning anything of a military nature.

- (1). Attention is drawn to K.R. (Can.) 1527 regarding the M.F.M. 6 Field Conduct Sheets. The following instructions are a summary of the rules laid down for the maintenance of Field Conduct Sheets, in accordance with the above quoted paragraph and also K.R. (Can.) 1523 (d).
- (2). A field Conduct Sheet will be prepared for every soldier.
- (3). Every conviction for an offence committed by a N.C.O. or man below the rank of Staff Sergeant or equivalent rank for which a punishment has been awarded will be entered in the field conduct sheet, except offences (other than drunkenness or those involving forfeiture of pay under F.R.&I) for which one day's C.B., one extra guard or one extra piquet has been awarded.
- (4). Conviction by Civil power will be entered only under provisions of K.R. (Can.) 1518 (b) (iii) and (iv).
- (5). A new conduct sheet will be prepared on which regimental entries only will be entered from the previous sheet:-
 - (a) On a recruit completing 6 months' service from the date of attestation.
 - (b) On a soldier completing 2 years consecutive service clear of a regimental entry.
 - (c) On promotion to the "substantive" rank of Sergeant.
 - (d) On promotion to the "substantive" rank of Staff Sergeant or W.O.
- (6). Regimental entries will only be shown on the Field Conduct Sheets of "substantive" Staff Sergeants or equivalent rank. Convictions by Court-Martial only will be shown on the sheets of "substantive" Warrant Officers.
- (7). Punishments constituting regimental entries are shown in K.R. (Can.) 1518.
- (8). Specimen Field Conduct Sheets will be prepared for the guidance of Squadron, etc., Commanders.

5. DENTAL TREATMENT.

It has been observed that some men are in the habit of reporting to the Medical Officer for authority for dental treatment on Tuesday and Friday mornings. It is considered strange that a long route-march should cause a man's teeth to give him trouble. In future, all men who drop out during route marches will be paraded, under Coy. arrangements, to the Medical Officer, and where necessary, disciplinary action will be taken.

7. BARRACK DAMAGES.

These are extremely expensive articles and care must be taken that they are not damaged. In future, any barrack damages will be investigated immediately; disciplinary action will be taken, and the cost of the damages will be assessed against the offenders.

Reports have been received that soldiers travelling as individuals on trains have caused considerable trouble to the railway authorities by creating disturbance in cars occupied by the general public. Complaints include:-

- (iv) Interference with civilian passengers, especially women.

2. It is also reported that soldiers with special rate tickets are travelling in plain clothes and that some soldiers have been travelling without railway tickets at all, and have refused, or been unable to pay the necessary fare.

3. It is pointed out that this reprehensible conduct by soldiers on leave, if continued, may lead to the railway companies having to withdraw the concessions granted by them in allowing all ranks of the C.A.S.F. on leave to purchase "round trip" tickets for single fare.

4. The attention of all ranks is to be drawn immediately to this unsoldierly conduct, which brings discredit to His Majesty's Service. Other ranks before proceeding on leave are to be warned regarding their behavior when in public.

5. DOMINION INCOME TAX RETURNS 1939.

A.Q. Circular Letter No. W/81/1940, dated 27th April, 1940, is re-published for the information of all ranks:-

1. Advice has been received from N.D.H.Q. that the departmental returns for the Dominion Income Tax, showing total pay and allowances drawn for the year 1939, will not be available on the 30th April as in previous years.
2. The question of penalty for failure to file return by 30th April, 1940, was taken up with the Income Tax Department for information as to whether such penalty would be imposed, and advice has been received to the effect that, under the Act as it stands at present, no assurance can be given that the penalty clause for late returns will not be invoked. Therefore it would appear that the delay referred to in Para. 1 above does not relieve the individual affected of responsibility for rendering his return to the Dominion Income Tax authorities on the proper date, and income tax returns should therefore be rendered by all concerned on or before April, 30th. Any difference between the amount shown in the departmental return and that shown in the return submitted by the individual, may be adjusted, when the departmental figures are made available, by rendering an amended return.
3. It should be observed that all pay and allowances drawn during the calendar year 1939, including dependents and subsistence allowances, are subject to income tax. Amounts deducted for pension, in the case of Permanent Force personnel, are not taxable.
4. It is suggested that those officers and other ranks who were provided with quarters, rations, fuel and light in kind, during this period, should include only two-thirds of the money allowance in lieu for income tax purposes.
