#### 5. DRESS AND AUTI-GAS PROTECTIVE EQUIPMENT

- a.Anklets will be worm on all occasions, except when off duty in the immediate vicinity of living quarters.
- b. Respirators will be carried by all ranks at all times, or placed in some readily available position.
- c.Sentries, Guards and Piquets, etc., whose duties require them to be outside will wear their respirators in the 'Alert position', capes rolled, and will wear 'detectors, individual'.
- d. In event of a 'Red Warning' or hostile enemy air activity, eyeshields will be put on immediately and capes carried in the worn position by all ranks not under cover.
- e.Capes anti-gas are NOT to be used as rain coats, and eyeshields, anti-gas are NOT to be worn on the brim of the steel helmet.

#### 6. GAS SPRAY ALARM

The Gas Spray Alarm is now the same as the local airraid warning and consists of a SERIES OF SHORT BLASTS OF THE WISTLE.

Every air attack must be regarded as a potential spray attack and all ranks whose duty requires then to be outside of those who for any other reason cannot find shelter must immediately adjust their eyeshields and bring their capes to the 'worn position'.

All ranks must be able to recognize gas spray leaving an aircraft (at 2,500 feet spray takes 2) minutes to reach the ground) and taught that their immediate action is to shout 'SPRAY', whereupon all troops within earshot will bring their capes, anti-gas, to the 'vorn position'.

The presence of gas, other than spray, will be indicated on the wooden trench rattle.

#### 7. CARRYING OF ARIIS

- (a) All Officers in possession of revolvers and all parties of troops and individual soldiers, when on duty away from the vicinity of their quarters, will carry arms and amounition.
- (b) Personnel when NOT on duty will NOT carry arms, excepting as indicated in para. (d).
- (c) All weapons when NOT with the individual will be safeguarded in accordance with A.C.O's 518 and 1278 of 1940
- (d) All Officers will carry revolvers and amounition while travelling in Government vehicles outside of their respective barrack areas.

#### S. MAIL

Personnel are permitted to send mail to Canada without postage, subject to the following conditions:-

- (a) All mail, as well as being clearly addressed, must be clearly marked on the front with the letters C.A.S.F.
- (b) Unit stamp shall be impressed on the back of each envelope, by Mail Orderly.
- (c) All such mail shall be collected by the Unit Mail Orderly and shall NOT be mailed in civil or other post boxes.
- (d) Mail for all other destinations than Canada shall require the usual postage,

#### 10. AIR-RAID WARNING

(Action of Troops Out of Barracks)

In the event of air-raid warning RED being sounded, troops at places of amusement or in the streets will return to their barracks if within reachof them.

The remainder will utilize such facilities (military and vivil) for protection as areavailable in he immediate neighbourhod, care being taken that protective arrangments for the civil population are not unduly encroached upon.

#### 11. UNIT STANDING ORDERS

The preceeding Orders will be applicable to the Unit until such time as Standing Orders are prepared and Coy. and Detail Commanders will ensure strict compliance therewith.

# 12. SPECIAL ORDER OF THE DAY BY MAJOR GENERAL V.W.ODLUM, C.B., C.M.G., D.S.O. COMMANDING, 2ND CANADIAN DIVISION The 2nd Canadian Division C.A.S.F., at last concentrated, now comes

under my command. With my first message I welcome it. I am proud to be its leader, and I pledge myself to give to it everything that I have or am. What I myself undertake, I ask of every officer and man. Together we can make this a great division -- and we will. We are not here merely to defend Canada and the Empire on British soil. We will not rest till we defend our homes on German soil.

Already I have taken steps to link this Division with the 2nd Canadian Division of the last war. On my car you will see a replica of the flag flown by the Divisional Commander of that older 2nd Division which helped to smash the armed might of the Germany of the Kaiser. In the Divisional sign on our transport and in the distinguishing patches we will wear on our shoulders, the spirit of the old Division will spring to life again.

The 1st Canadian Division, which preceded us to England, is recognized as a powerful striking force. Our immediate task is to fit ourselves to take our place beside them, when a new Canadian Corps will come into being. We want to be as proud of it as Canadians were of the Canadian Corps of 1914-18; but we can only be proud of it if we are proud of outselves.

Let us not fail Canada, even in little things, at this hour. Her honour, her prestiage, are in our hands. In training or in fighting, in discipline, in conduct off duty -- whereever we are, remember that while we wear 'Canada' on our shoulders we must guard Canada in our acts, and cherish Canada in our hearts. To fail her is to fail our own loved ones.

With character, intelligence, offensive spirit and discipline on our side, nothing can stop us. Again I welcome you all to the task we have undertaken for Canada, for the Empire, for a great democratic cause-- and for the emblems of them all, our King and our Queen.

  - (2) Location or movement of any naval, military or air force units or detachments, arrival or lack of reinforcements.
    - (3) Criticisms and statements calculated to bring into disrepute our forces or those of our allies
- (b.) It is forbidden to send, or to attempt to send, to unauthorized persons:
  - (1) Official documents, including intelligence summaries, orders, reports, maps, etc., or to disclose their contents except in the course of duty.
  - (2) Any document captured from the enemy, or found in places occupied by the enemy, and any document containing information about the enemy.
  - (3) Any official document belonging to the civil authorities in allied or enemy territory.
  - (c) It is forbidden to despatch to neutral or enemy countries photographs or pictorial matter of any kind, from whatever source they may have been obtained.
  - (d) It is forbidden to communicate to the Press, except through the duly authorized channels.
  - (e) It is forbidden to send through the post photographs or films, except those taken under proper authority. The procedure in this regard is laid down in C.A.S.F. (Overseas) Routine Order No. 95.
  - (f) It is forbidden to insert advertisements or letters in any publication, inviting correspondence with strangers, or to enter into correspondence with any stranger in response to such advertisements or invitations.

#### 6. PHOTOGRAPHS -- TAKING AND CENSORSHIP OF:

C.A.S.F. (Overseas) Routine Order No. 95 is published for the information of all ranks:-

- (a.) Officers and other ranks are NOT to photograph any weapon or other form of military equipment of which a picture has not previously been reproduced in the press.
- (b.) Any photograph (other than of the sender and/or other persons in which no weapon and military equipment appears) which a member of the C.A.S.F. desires to send from this country will be submitted to his Commanding Officer for censoring prior to despatch.
- (c.) Commanding Officers will be responsible that no photographs which contain information of military value to the enemy are approved for despatch.
- (d.) In cases of doubt, the Commanding Officer may obtain a definite ruling as to whether or not the photograph should be approved from:-

The Photographic Department, Press & Censorship Bureau, Malet Street, London, W. C. 1.

(e.) Photographs sent to that office should be accompanied by a stamped and addressed envelope in which the photographs may be despatched to their destination.

#### 7. TROOPS ON THE MARCH (Observance of Traffic Lights):

Divisional Order #120 is published hereunder, for the information of all ranks:

"A number of instances have come to notice recently of columns of troops disregarding traffic lights. In some of these instances serious accidents have only been narrowly averted.

In cases of urgent operational necessity, such as troops moving to take up positions in battle, strict observance of traffic lights can be waived. At all other times columns of troops will observe traffic signals in the same manner as other road users. In this respect columns of troops on main roads are governed by the same regulations for W.D. Vehicles under para. 4 of A.C.I. 228 of 1940. When the lights turn to red, that portion of the column which has not passed the lights will halt. The space in a column thus caused will, if necessary, susequently be made good by an increase of pace in the rear portion of the column and a similar decrease in the leading portion."

To avoid casualties and to give due warning to drivers of motor vehicles, the following action will be taken by all troops using roads on which motor vehicles might be encountered:-

i. By Day:
All parties of troops will be protected both in front and rear
by two men, some 50 to 100 yards from the main body, whose duty
will be to warn all approaching traffic by means of hand signals.

ii. By height or in Foggy Weather:
All parties of troops will be preceded by two men, some 10 yards aheadd, the offside man carrying a lamp(hurricane, with a blue and white globe). Also they will be followed in the rear by two men, at some 10 yards dis tance, the offside han carrying a lamp(hurricane, with a blue and red globe).

The system of moving with files on both sides of the road will not apply at night: also, companies will move closed up and not by independent platoons.

Lamps(hurricane, with the necessary globes), will be issued by the D.A.D.O.S., Aldershot Area, Field Stores, on receipt of indents, to infantry battalions on the scale of twelve lamps: six with blue and white globes, and six with blue and red globes.

Battalions already in possession of hurricane lamps will exchange these for lamps suitably painted in accordance with the above order. Lamps so drawn will be returned to Field Stores by battalions on

iii.Vehicles:

An electric sign for attachment to the rear vehicle of a convoy, ahowing the words: "DANGER, CONVOY", is available from Command H.Q. on receipt of demands. The rear vehicle of all M.T. convoys moving at close spacing or motor-roads at night will be equipped with one of these signs.

#### 3. DISCIPLINE: D.R.O. No.147.

Attention is directed to Div. R.O. No. 13/1940: Officers commanding will impress upon those under their command that dispersion is the best method of avoiding casualties from Air Raids and that the crowding of soldiers into the streets of Aldershot and other towns, especially after dark, makes control difficult and greatly increases the chances of casualties.

In view of the above, personnel should be discouraged from proceeding into towns merely to sightsee, and those who have business to do should transact it as quickly as possible and then get away from the crowded streets.

- (b) In brick buildings: An announcement will be made to the effect that an air raid warning has been received and members of the audience who wish to leave will be allowed to do so. The performance may then continue. At the end of the performance, in order to avoid risks incurred by a large crowd emerging on the road at the same time, arrangements will be made for the audience to leave in small parties.
- (c) In wooden buildings: The performance will cease and the audience will leave: those within reach of them returning to barracks, the remainder dispersing from main thoroughfares and availing themselves of such cover in the vicinity as is available.

For military theatres, cinemas, etc. Area Commanders will issue instructions on the above lines.

#### 6.AIRCRAFT BOMB CRATERS:

Bombs landing on soft ground sometimes penetrate deeply before exploding, and then blow a large hole below the ground level, with very little access to the air. The crater so formed then fills with carbon-monoxide, a deadly gas, against which the service respirator GIVES NO PROTECTION.

There is often a comparatively thin crust of earth around the bomb entrance hole, and lives have been lost owing to men approaching too closely and falling through the crust: being overcome by carbon-monoxide.

All ranks will therefore be warned to take great care when approaching bomb-holes.

# 7.DISCIPLINE - Safety precautions to be observed by Troops walking out in the hours of darkness:

- (1) Owing to the regrettable number of accidents involving loss of life, which have occurred during the hours of "black-out", it is considered desirable that the attention of all ranks should be drawn to the necessity of taking the normal precautions when walking in public thoroughfares at night, when off duty or on duty as individuals. It should be pointed out that drivers of vehicles are often unable to see pedestrians, particularly those dressed in Khaki, in sufficient time to avert an accident.
- (2) In places where no footway is in existence and it becomes necessary to walk on a roadway, pedestrians should walk on the right-hand side of the road: i.e., against the oncoming traffic, and NOT on the left-hand side, where there is always the danger of being run down from the rear by overtaking traffic.
- (3) All traffic signals must be observed, and thoroughfares crossed only at the appointed pedestrian crossings when these are available.
- (4) The foregoing instructions will be brought to the notice of all ranks at least once a month, in order that the loss of life through lack of care and attention in this matter may be checked.
- (5) Personnel soliciting lifts from vehicles after dark incur grave risk to themselves and the driver of the vehicle. Such action will therefore be dealt with severely.

(c) It has been found that other rank personnel require approximately 15/ per diem if they proceed on furlough to LONDON. Officers Commanding will ensure that the period granted will NOT exceed that for which the soldier has sufficient funds to maintain himself. .(d) The greatest care must be taken to ensure that other ranks proceeding on leave are in possession of duly completed passes, and that the conditions of leave are stritly observed. Each man will have clearly marked on the back of his pass the place to which he is to report if recalled in the event of an emergency. (e) Should hostilities commence in the United Kingdom, broadcast will be made, informing all troops on leave to rejoin their units immediately.

Telograms will be sent only in exceptional cases. Should rail traffic be held up, men will be so informed by the railway authorities, and they will then report immediately to the nearest Military unit or Depot.

(f) Personnel will NOT travel on trains on Saturdays or Sundays except

in case of emergency vide sub-para (e).

#### Conduct of Personnel on Leave:

(a) Troops on leave are much in the public eye. Good behaviour and manners, a smart and soldierly bearing, and attention to saluting at all times, will go far to maintain the high prestige of all Canadian Units. (b) The Military Police, who maintain a close liaison with the Civil and Metropolitan Police, are empowered to deal effectively with all breaches of military discipline.

#### Personal Finance and Accommodation:

All ranks must be made familiar with English currency and its comparative value in Canadian Funds. Commanding Officers must ensure that Other Ranks proceeding on leave are in possession of sufficient money to cover the authorized period of leave. If a soldier lacks such, leave should not be granted, or should be reduced commensurate with his available funds. All ranksshould be in possession of return transportation when proceeding on leave. On any occasion where the individual travels on leave at his own expense the existing half-fare arrangements are applicable on presentation of the soldiers' pay-book or his pass; or of the Officer's Identity Card (A.F.B. 2606).

Accommodation is available in LONDON, at reduced rates for Officers in various hotels, and at cheap and reasonable rates for other ranks in various hatels and clubs, which cater exclusively to the needs of soldiers on leave. Information in this regard may be obtained from the R.T.O.s. Office at allthe large London Railway Stations, or from Information Khosks which have been set up for the purpose.

## Advances of pay:

No advances of pay to personnel on leave will be issued by the Canadian Pay Office, Acton, and all ranks must be informed of this fact. Advances must be drawn through Unit Paymasters before proceeding on leave. Other ranks are to be informed that when an individual finds himself stranded without funds and without return transportation, he will report as follows:

Personnel who wish to be granted permission to visit Eire will submit their application through the usual channels to the Bn. Orderly Room. Should permission be granted personnel will wear plain clothes through the whole period of their leave, including travelling in the U. K.

All military equipment will be left under the care of Coy. Q.M.S.s.

Leave Passes will be endorsed in red ink: "This pass is valid for Eire and Northern Ireland only if A.B.64 Part I can be produced by the holder in proof of his identity".

The soldier's pay-book M.B.M. I will be checked to ensure that details on pages 2 and 3 of Part I have been filled in. Distinctive marks on hands and face which may be readily discerned should be noted to facilitate identification.

The above instructions apply equally to personnel proceeding to destinations in Northern Ireland, except that equipment will be worn. Arms., etc., will not be carried.

Personnel on leave travelling in Northern Ireland will travel by public service on Stranraer-Larne route. They will not travel by other civil routes nor by special trains and ships arranged for leave from Northern Ireland.

They will cross only on Tuesdays, Wednesdays, Thursdays, and Fridays, and will return on a similar day of the week.

#### 2. DRESS:

The following extracts from C: A. S. F. Routine Orders (Overseas) are published for the information of all concerned:

(a). Full dress and mess dress will not be worn on any occasion.
(b). Undress may be worn by all ranks in the evening. This dress will be optional and it is emphasized that individuals not already in possession of it will not be required to provide it against their will. It will not be worn during the day on any occasion.

Officers proceeding out of barracks or camps in this dress will wear the Sam Browne belt (without brace or frog) of a cloth belt of the type (in the material and colour of the jacket) approved for wear with service dress . Officers of Scottish regiments may alternatively wear the Sam Browne belt with one brace. Officers of Rifle regiments may alternatively wear the black patent leather shoulder belt with pouch instead of the Sam Browne belt. In keeping with the pre-war policy, other ranks will not wear belts with undress.

(c). Officers and other ranks from an expeditionary Force on leave in the United Kingdom and Northern Ireland may regard the wearing of uniform on leave as optional.

(d). All ranks, whether or leave or at their stations, may be permitted to wear plain clothes for the purpose of athletic exercises for which a special dress is necessary. (e). Except as otherwise provided above, service dress or battle dress

will be worn by all serving personnel on all occasions.

- (f). The wearing of decorations and medals will cease. Medal ribands will however be worn on undress, service dress, and battle dress.
- (g). The carrying of regimental or other types of canes and whips by other ranks will cease.
- (h). Officers and Warrant Officers carrying revolvers may, at their discretion, wear a brace with the Sam Browne belt.

#### 4. DISCIPLINE:

The following communication from Headquarters, South Aldershot Sub-area is promulgated for the guidance of all concerned:-

2. In future, ground sheets will be rolled and the pack kicking-straps will be looped by using the knuckles around each end of the rolled ground sheet. The kicking-strap loops will be appeaximately 2 inches from each end.

3. The free ends of both kicking-straps will be placed over the shoulders on top of the web equipment, run through the second rung of the attachment on which the pack is hung, and then tucked down behind the pouches.

4. The ground sheet will be worn on the back immediately below the rolled gas cape.

5. Length of the rolled ground sheet should be approximately 12 inches.
